1. Introduction

The Directorate-General for Health and Food Safety (DG SANTE) develops and implements the Commission's policies on food and feed safety, animal health and welfare, plant health, import controls and public health. It has a Directorate located in Ireland, that notably monitors the implementation and enforcement of its policies by conducting audits and other controls in EU Member States and in third countries exporting or wishing to export plants, animals and food to the EU. This is essential for ensuring that EU policy objectives are met and for citizens to be confident that their interests are protected.

This document provides the programme of audits and other controls on food and feed safety, animal health and welfare, plant health and import controls for 2027.

2. Objectives and role of controls performed



In the EU, **operators** in the agri-food chain (such as farms, slaughterhouses, food-processing establishments and importers) have the primary responsibility for ensuring compliance with EU safety standards.

In turn, competent authorities in the **Member States** are responsible for checking operators' compliance, by means of official controls. Member States also have to set up a system to assure themselves that they carry out their official controls effectively and consistently.

Competent authorities in **third countries** exporting to the EU are also responsible for performing effective official controls to guarantee that their exports to the EU meet Union's health, safety, and quality standards.

Commission audits verify the effectiveness of official control systems in the Member States and third countries exporting food, feed, animals or plants to the EU. They also play a central role in the authorisation of a third country to export animals and animal products to the EU market.

The Commission publishes an audit report after each audit ⁽¹⁾, which may include recommendations to the competent authority to address systemic or significant non-compliances identified. Also published is the competent authority action plan addressing the recommendations.

Besides audits, the Commission also carries out

- assessments in the context of the ongoing **EU pre-accession negotiations**, to evaluate the progress of the candidate country with the implementation of the *acquis* regarding food safety, veterinary and phytosanitary policy in view of future accession to the EU.
- fact-finding visits in anticipation of the applicability of legal requirements, or in areas where the Commission needs to complete its knowledge about the operation of legislation. The results of these visits support evidence-based policy review or development, guidance to assist Member States, and the preparation of subsequent audit series. The approach is very similar to that used for audits.
- overview reports providing a summary of how a particular sector or piece of legislation is implemented based on the outcome of audits, fact finding visits, or desk-based surveys.

3. Audit priorities for 2027

The programme of audits takes account of the risks posed in the various policy areas and aligns with the Commission political priorities, notably the priority area of 'Food security, water and nature' ⁽²⁾ and the Commission's 2025 [Vision for Agriculture and Food](#).

In 2027, the Commission plans to perform 144 audits in the areas of food and feed safety, animal health, animal welfare, plant health and import controls. In addition, 8 fact-finding visits will be programmed. The proportion of audits of Member States amounts to 45%, a decrease compared to previous years, as a result of an increased focus on trade-related audits and support to pre-accession.

The programme of audits for 2027 is designed to meet Commissioner Várhelyi's commitment to reinforce controls on products imported into the EU, with the objectives of increasing (i) the number of audits of third countries by 50% to verify that they provide sufficient guarantees that their exports meet EU standards, and (ii) the number of audits on EU border control posts by 33%, to verify that Member States carry out border inspections in line with EU requirements. Both increases are relative to 2025.

Of the 144 audits, the objective for 2027 is to perform, on the ground, 58 export related audits of third countries. This represents an increase of 107% compared to the number performed in 2025. Furthermore, with eight audits planned in 2027, the number of audits on import controls at European Border Control Posts increases by 60% compared to 2025.

Support to the pre-accession process remains a priority for the programme of audits 2027, with 12 audits planned to candidate countries.

The 2027 programme will continue to contribute to One Health, with four specific fact-finding visits planned for advancing the 'One Health' approach, in addition to the numerous planned audits bearing a One Health dimension.

The prioritisation of topics and countries takes account of legal requirements, food safety and health risks (associated with products, their origin, production or trade volumes, evidence of non-compliance, and the outcome of past audit activities) and policy considerations.

The programme can be adapted to circumstances (such as emerging risks or crises, new political priorities, or security issues).
